#### KESWICK TOWN COUNCIL 17 JULY 2025

Proposal for Cumberland Council

Following on from last month's decision to bring this report back to Council this month, Councillor Harwood has added the following information, underlined in this report.

"Keswick is a prominent tourist destination in the National Park which provides significant income to the economy of Cumberland. The Town Council's ownership within the town is restricted to Hope Park and Fitz Park, including Townsfield, which are maintained to a high standard on a limited budget from the Council Tax Precept. It is evident that parts of the town have a run down appearance which shows a sign of neglect and does not reflect well on the importance of maintaining a high visual standard in all areas. Voluntary groups, such as 'Keswick in Bloom' provides award winning colour to the town throughout the year from individuals who give their time freely. However there are many key areas which require specialist contractors to carry out maintenance and repair work to keep the town looking its best. Whilst every effort is made by the Town Council to do what we can, we are faced with having to maintain a town serving 30K people on the Precept of a resident population of 5K.

We propose that Cumberland Council award a grant each year equivalent to 10% of the income generated from Keswick Car Parks to enable The Town Council to carry out an agreed programme of work to rejuvenate designated areas of the town, irrespective of ownership. As the party on the ground we are aware of the areas which would benefit from renovation work. This simple award each year would put finance back into Keswick which would benefit Cumberland Council enormously by saving the time and effort in doing this work. It would also showcase the town in the best possible light as one which is looked after by its local Council.

This proposal is not intended to be a criticism for lack of action in the areas concerned. Cumberland is a large geographical area and it is appreciated specific local knowledge in all areas is difficult to cover. This is considered to be a fair and reasonable way of putting finance back into our local community from income generated in the way outlined to make use of local knowledge. It will benefit both parties by investing in the town's ability to maintain a high quality visual experience to our many visitors throughout the year. I set out below some key areas which would benefit from this grant.

- It is envisaged KTC would employ a project manager to liaise with CC and organise / oversee the work involved.
- Renovation works to paving and walls to the walkways leading into the Market Square from town centre car parks.
- Regular cleaning of the pedestrianised areas in the town centre to address the unsavoury atmosphere created by the high number of dogs brought into this area.
- Repainting the significant extent of rust covered railings along Penrith Road which is a main access route into the town.
- Renovation works to the paved areas and external seating on the well used Lake Road walkway to the Lakeside.
- Support where required for the Keswick in Bloom team which does so much to bring colour into the town throughout the year.

- Repainting is overdue to Wivell Bridge over the river leading into Upper Fitz Park and Silver Bridge on Station Road.
- A new retaining structure is required to a section of the riverside wall near Silver Bridge to replace a failing timber structure to maintain the integrity of the riverbank in Lower Fitz Park.
- Formation of a durable access track from the top end of Stanger Street to the public footpath ramp down to Knight's Bridge into Fitz Park which is suitable for pedestrians and vehicles.
- Essential repair works to Carding Mill Lane leading into the Southey Hill Industrial Estate which provides access to many local businesses. This is in a very poor state of repair which reflects badly on the town.
- Assisting CC with maintaining the much reported poor condition of the Howrah's public footpath from the town to Portinscale which is an integral part of the Cumbria Way round the lake walk route.
- Renovation and reinstatement in a user friendly way of the stepped footpath at the bottom of Manor Brow."

Councillor Harwood recommends that the above proposal be approved, and a letter sent to Cumberland Council.

#### Nature recovery

You might have seen <u>media coverage</u> of a letter best-selling author and conservationist Lee Schofield wrote to UNESCO recently.

In it, he argues that World Heritage Status – and its focus on the cultural heritage of sheep farming - compromises land-owners' ability to deliver nature-recovery projects. The RSPB have supported this stance: they manage the huge nature-recovery project Haweswater, which up until recently combined outstanding nature-recovery outcomes, with low density sheep flocks. Now, however, they have removed all their sheep and will only 'bring in low numbers of sheep as a tool for short periods, on certain parts of the site where it is appropriate'.

The LDNPA's approach is that nature recovery and traditional hill farming can go hand-in-hand. It's even in our Statutory Purpose, which is: to 'Promote opportunities for the understanding and enjoyment of the special qualities the national park by the public.' Special Quality number four is 'Unique farming heritage and concentration of common land'.

There are many great partnerships working to deliver nature benefits <u>and</u> successful farming outcomes – the <u>Ullswater CIC</u> (led by Danny Teasdale) is a brilliant example; and there are hundreds of individual famers doing great work – the most well-know of which is of course, James Rebanks. Our officers are working with all these different parties – from huge land owners like UU and Lowther, to farmer collectives like the Ullswater CIC and to individual farmers like James; to strike the right balance between nature-recovery, cultural heritage and successful farming.

Most of the reaction I have seen to Lee's intervention has been critical of it. For example, Tim Farron MP, described it as a 'misguided and poorly judged attack on hill farmers.'

But the debate continues on: the CEO of the National Sheep Association wrote to the Guardian saying 'Farmers want to continue looking after the land they have farmed for centuries, ensuring public access, balancing farming with nature, and managing the landscape in a viable way for future generations' and Lee Schofield replied with a letter in which he says 'For farmers and conservationists to be at loggerheads is madness. Once the dust settles, I hope we will be able to sit down and have some sensible discussion about these issues and how to resolve them.'

#### Summer solstice at Castlerigg Stone Circle

I went up to the stone circle twice over the solstice weekend. On Saturday I met Neil Winder from the National Trust and Jack Beament (who lives in the house nearest the stone circle) to discuss the problems and some of the mitigations that have been put in place this year.

The Strategic Visitor Management Group (which the LDNPA chairs) funded a team of three security staff who were on site for two nights, from 4pm through to 9am the following morning. While there was still some fire damage and litter we can only hope that their presence, generally engaging positively with people, helped to *reduce* antisocial behaviour. They did have trouble with one small group of antisocial people who were letting off fireworks, but the police attended when called upon.

Parking, however, was a major problem with a significant stretch of the road in-accessible to emergency vehicles, should they have been needed. In our discussion Neil and I agreed that finding a suitable field for a 'pop-up' carpark is a priority for next year. Also funded by the SVMG were a number of toilets and extra bins which definitely helped reduce the negative impacts of the event. Finally, NT Rangers, LDNPA and English Heritage volunteers helped tidy up the site on the Monday morning.

A significant investment has gone into managing the event this year, and while there are still challenges, I think we're moving in the right direction.

#### **Electric boats on Bassenthwaite**

On Sunday I joined Marcus Campbell-Savours MP and Cllr Mark Fryer (Leader of Cumberland Council) to hear concerns from local fishermen about the potential impact of proposed changes to local bylaws on their ability to use small electric motors to power small fishing boats. I was able to explain that the intention behind the proposal is to prevent electric speed boats – which can travel at 40mph – from accessing the lake, not to penalise local fishermen.

#### (contd)

Proposals are already in place to allow exceptions for slow, low-power fishing boats and officers will consult further on how such exceptions should best be worded to meet the aims, we agreed, we all had in common. I also got to enjoy a quick trip out onto the lake.

#### Operation Alliance: Drug supply targeted across Cumbria

Four policing operations targeting drug supply in Cumbria has seen 26 arrests, seized over half a million in cash and thousands of pounds of drugs taken off the streets.

The operations, Apache in Penrith, Abington in Barrow, Bologna in west Cumbria, Huelva in Carlisle were funded by the Police, Fire and Crime Commissioner



David Allen as part of the Drugs Fund. The fund takes money recovered from drug activities to target further those dealing and supply drugs.

The four days of action seen officers conduct 18 warrants and 15 stop searches, recovering:

- £612,300 in cash
- 81 cannabis plants
- Over 2,000 cannabis edibles and vapes
- Over 200 Pregabalin
- Numerous recoveries of cocaine, cannabis (herbal), Ketamine and other benzodiazepine

- Numerous weapons including samurai sword, knives and air rifles.
- Illicit Tobacco and cigarettes
- Cryptocurrency and associated paraphernalia.

# Celebrating volunteers – National Volunteers' Week 2025

This week (2-8 June) Cumbria Police are recognising the amazing contributions that volunteers make to our organisation.

Volunteers hold various different roles within the constabulary such as Police Support Volunteers (PSVs), Special Constables (volunteer police officers), cadets and cadet leaders, who all give up their free time to help keep Cumbria safe.



Over the past year, a team of 37 Special Constables volunteered 11,191 hours with 4000 duties assisting both response and rural officers, and 260 duties policing some of the county's major events and operations. These hours volunteered equate to almost six full time officers throughout the year.

The force is also supported by 65 PSVs in roles in our cyber, rural, road safety and quality assurance departments. We also work closely with many young people across the county as part of our cadet programme and are supported by 24 volunteer cadet leaders. **Read more here.** 

#### Statistics place Cumbria as one of the best performing forces in the country

A national survey has found Cumbria Constabulary to be the number one force in England and Wales for understanding residents' concerns, with most people having confidence in local policing — and the majority of those asked in our county agreed officers in their community can be trusted.

Results from the survey, used by the Government to measure crime and develop ways of tackling it, also revealed:

- Nearly 85 per cent of people surveyed agreed police in Cumbria would treat them with respect.
- More than 72 per cent had overall confidence in policing in Cumbria placing the county in the top five nationally.
- Cumbria was second in England and Wales for the percentage of people who agreed the force and their local council were dealing with the anti-social behaviour and crime issues that mattered.

Assistant Chief Constable Jonathan Blackwell said: "I am extremely proud of all the positive results the force continues to achieve.

"We are here to serve this county and our communities – and one of the best measures of how successful we are at doing so is what our residents think about the policing service they receive.

"What is particularly pleasing is most people taking part in this survey agree we understand their concerns and are proactively tackling anti-social behaviour and crime.

"It is also a reflection of the professionalism, empathy and caring nature of officers and staff that most people agreed they would be treated with respect and that they had overall confidence in what we do." Read more here.

#### 101 calls answered in just three seconds in Cumbria - national figures show

Cumbria Police's 101 call-handling was recognised as among the best in the country yesterday (29 May).

The national league tables for 101 non-emergency call waiting times reflects a national reduction in the time people are waiting for their call to be answered to 32 seconds. However, in Cumbria the waiting time is significantly shorter at just three seconds.

Chief Constable of Cumbria Constabulary Rob Carden said: "Reducing the waiting times on our 101 non-emergency line is a priority in Cumbria, and I am very proud to see that work recognised nationally through the results that were published this week.

"We have consistently been one of the best performing forces for 101 waiting times in recent years, which is why I'd like to take this opportunity to thank those officers and staff who work day-in and day-out in the Call Management Centre."

In Cumbria, the public are given a number of options for contacting the Constabulary in an non-emergency situation so people can opt for whatever works for them — whether online or via a phone call, with those opting for online helping keep the phone lines free for emergency 999 calls. **Read more here.**





#### Neighbourhood Policing Week (23 - 29 June)

Throughout the week we have been highlighting and sharing some of the work we do all year round to help reduce crime and keep people safe.

#### Anti-Social Behaviour Week - 30 June - 6 July 2025

At the start of July we took part in Anti-Social Behaviour (ASB) Awareness Week, a national initiative running from 30 June to 6 July, aimed at highlighting the impact of ASB and promoting safer, stronger communities.

This year's theme, **#MakingCommunitiesSafer**, focuses on supporting victims, improving justice system responses, and encouraging better information sharing between agencies.

In January, we launched the Neighbourhood Policing Pledge, which aligns us to the national pillars of Neighbourhood Policing and ensures we deliver the government

Neighbourhood Policing Guarantee. The pledge focuses on ten core priority areas of neighbourhood policing, one of those is tackling crime and anti-social behaviour.

As a priority, we launched Operation Enhance in July 2024, which has seen extra patrols in 18 areas identified as hotspots for ASB and serious violence. The operation whilst also being a visible presence has seen officers numerous arrests, stop searches, fixed penalty notices, community engagement and support given to local businesses.

As a result of Operation Enhance and the hard work carried out by the neighbourhood policing teams, the hot spot areas have seen a reduction in ASB by 35.2% between 1 July 2024 and 31 March 2025 compared to the same period in the previous year.

In relation to incidents of ASB involving young people in the hotspot areas over the same period there has been a reduction of 39.4% compared to the previous period.

Operation Enhance will continue throughout 2025/26.

Chief Superintendent Andy Wilkinson, the force's Neighbourhood Policing lead, said: "Anti-social behaviour (ASB) is a priority, and this week highlights the work our teams and partners do every day to tackle anti-social behaviour.

"As well as responding to incident of ASB, a great deal of work is carried out behind the scenes to prevent further incidents occurring.

"ASB has a detrimental impact on our communities and encourage the public to tell us about incidents that are happening in your local area.

"Reporting allows us to create a picture of activity and allows to take appropriate action to investigate and deter further incidents."

Councillor Judith Derbyshire, Cabinet Member for Housing and Community Safety at Westmorland and Furness Council, said: "Anti-social behaviour causes real distress and disruption to residents' lives and has a damaging impact on our communities.

"The multi-agency work of the Community Safety Partnership and Local Focus Hubs is proactively delivering initiatives that address complex cases of ASB in our communities using education, support and, where necessary, enforcement. Alongside Cumbria Police and partners, our efforts bring us closer to achieving our vision of making Westmorland and Furness a safe and welcoming place to live, work and thrive."

Justin McDermott, Cumberland Council's Executive Member for Public Health and Communities, said: "Cumberland Council staff and councillors will be out and about all week talking to residents about their ASB concerns. With colleagues from the Community Safety Partnership, we hope to get a real insight into the effects of antisocial behaviour, which can have an incredibly negative impact on people's wellbeing.

"We'll also be sharing the help we offer through our Local Focus Hubs and, more strategically, through the Community Safety Partnership – which has ASB as one of its four main priorities."

The class engaged so well and learnt lots from the session.

It's so important to educate children on this topic.

Some things discussed were:

- how victims of ASB can feel.
- what ASB is and how ASB could lead to a crime.
- how using public spaces, including play areas should be used respectfully.

These visits help neurodivergent people that have been affected by anti-social behaviour.

Year 4 were very knowledgeable with some excellent questions asked.

This allows local residents to report any drugs activity anonymously.

#### You said, we did - speeding Eaglesfield


We had reports of speeding in Eaglesfield, as a result we have carried out high visibility patrols.

Speed checks have also been used with the handheld laser as well as a traffic survey conducted by Cumberland Council.

**OPERATION ENHANCE**: Tell us your thoughts about antisocial behaviour and violence hotspots in Cumbria

We, the Police and Crime Commissioner and partners have secured £1 million of extra funding which will see extra patrols in 18 areas, identified by statistical analysis as the county's hotspot areas of anti-social behaviour and serious violence.

These areas include areas of Carlisle, Barrow, Workington, Whitehaven, Kendal, Penrith, Maryport, Cleator Moor, Ulverston and Bowness-on-Windermere.

Cumbria Police is supporting a national 'Ninja Sword' amnesty, ahead of a ban on owning such weapons coming into effect.

From August 1, it will be illegal to possess, sell, make or import the weapon. Those who currently possess a Ninja sword will not be permitted to keep it once the order comes into effect, unless a specific legal defence applies.

Ninja Swords are a sword which has length of at least 14 inches, but no more than 24 inches in length. The sword must have the following:

- A primary straight cutting edge
- A secondary straight cutting edge
- A blunt spine
- And either a tanto style point or a reversed tanto style point

Ahead of the ban coming into place, a surrender scheme is taking place from today until July 31 to allow people to hand them in.

Please follow guidance on the Home Office website and have the relevant paperwork completed before handing in the swords before visiting a police station.



#### O Police Constable Degree Apprenticeship


Did you know you can join Cumbria Constabulary as a degree apprentice and work towards a degree whilst serving as a student officer with active frontline duties?

This is a two year programme which gives a blend of practical on-the-job experience and classroom-based learning.


Once you leave training school, you will then go onto to your allocated station then eventually go onto independent patrols and will be assessed for the remainder of the two-year programme.

To be eligible to apply, you will need to have taken a three-year BSc professional policing programme offered by universities that are licensed and validated to deliver the degree by the College of Policing.





#### Partners working together to keep our town centres safe

Organisations across Cumbria are coming together this summer to keep town centres safe. The project, called Safer Streets Summer Initiative, introduced by the Home Office, launched today (Monday 30 June 2025) and runs for three months.

The initiative will be locally led by Cumbria's Police, Fire and Crime Commissioner (Commissioner), David Allen, and includes partners such as Cumbria Constabulary, Cumberland

Council, Westmorland and Furness Council, Public Health, Cumbria Fire and Rescue Service, Remedi, The Well Communities and Cumbria Youth Alliance.

The project aims to highlight the positive partnership work taking place over the summer to reduce anti-social behaviour (ASB), reduce and prevent crime and restore confidence in local and will focus on Carlisle, Whitehaven, Workington, Kendal, Barrow-in-Furness, Penrith and Ulverston town centres.

Some of the work that will be promoted throughout the next three months include: the work of the Restorative Hope Workers; the benefits of the Commissioner's Community Fund for local groups; partners' use of fines, Public Space Protection Orders (PSPO), and use of Community Protection Notice; youth engagement activities and diversionary activities; work with local drug and alcohol treatment services; work with local businesses to tackle retail crime; tackling knife crime; and protection and prevention measures in place to protect those enjoying the county's night-time economy.

#### Temporary Superintendent Annette McClement, Cumbria Constabulary said:

"The summer months can be an incredibly busy time for our county, with large numbers of people visiting our area to attend events and experience all that Cumbria has to offer. Therefore, it is also one of the busier periods of the year for our policing teams.

"The Safer Streets Summer campaign will highlight the work we and our partner agencies do to keep people safe in town centres across our county.

"Our force is committed to providing visible and effective neighbourhood policing to prevent crime and anti-social behaviour.

"It is vital to have the trust and confidence of communities for us to carry out our work to keep people safe. A recent national crime survey placed ourselves as the leading force in the country for understanding residents' concerns and highlighted the confidence people have for police in Cumbria dealing with issues that mattered to them.

#### Operation Spotlight road safety enforcement to target the Fatal Four

Cumbria Police is supporting a nationwide Fatal Four road safety campaign running throughout July - Operation Spotlight.

The operation targets the Fatal Four - speeding, using a mobile phone at the wheel, not wearing a seatbelt and driving under the influence of drink and/or drugs – and the April Operation Spotlight resulted in more than 150 arrests in the county.

Inspector Jack Stabler of Cumbria Constabulary lead's the Roads Policing Unit and is Chair of Cumbria Road Safety Partnership.

He said: "Our officers are on the roads 365 days a year targeting dangerous driver behaviour.

"However, Operation Spotlight gives us the opportunity to shine a light on the most dangerous factors which can result in deaths and serious injuries on our roads.

"I urge everyone to analyse their own driving behaviours and those of their passengers and loved ones. By taking a critical look at our own behaviour and the behaviour of those around us, we can save lives."

# Police education programme rolls out across schools in Cumbria

An educational programme to improve children's understanding of risks, citizenship and the law is being rolled out to schools across Cumbria. Pol-Ed is a suite of free educational resources created by subject matter experts to assist teachers of children, aged four to 18.

The programme has been live for two weeks with more than 100 schools already registered. To date, the resources have been used across 120 sessions reaching more than 3,700 students. The resources are being used in Personal, Social, Health and Economic (PSHE) lessons - covering topics such as consent, bullying, grooming and balancing freedom and the law. The Pol-Ed programme has been used by several police forces since being developed by West Yorkshire Police in 2021.

The programme in Cumbria is funded by money seized from criminals and distributed to police forces via the Asset Recovery Incentivisation Scheme (ARIS). **Read more** <u>here.</u>

#### Opportunity to surrender 'Ninja Swords' ahead of national ban

Cumbria Police is supporting a national month-long "Ninja Sword" compensation surrender throughout July.

The surrender begins on 1 July 2025 and is being run prior to it becoming illegal to possess, supply, sell, manufacture, or import a Ninja Sword from 1 August 2025.

This is a surrender compensation scheme so people surrendering qualifying items will be entitled to compensation via the Home Office.

Chief Inspector Sam Turner of Cumbria Police said: "This is an opportunity for people in Cumbria to surrender their items before they become illegal, in a safe manner and without fear of repercussions."

"Ninja Swords" can be handed in at the following police stations throughout July:

#### Cumberland

- Carlisle
- Whitehaven
- Workington

#### Westmorland and Furness

- Barrow
- Kendal
- Penrith Hunter Lane

People who hand in their "Ninja Sword" at a police station and are seeking compensation will be provided, upon request, with a Surrender Compensation form to complete.

(Those wishing to claim more than the standard compensation need to provide appropriate proof of ownership and purchase to support the claim, at the time of surrender.)

People are urged to take care in transporting their item to a police station. They should ensure they do so safely and in a way that does not cause alarm to others. The item should remain covered securely stored until a police officer or member of police staff invite the owner to unwrap or otherwise present the item.


